Our America has since grown from a loosely organized confederation of colonies scattered along the Atlantic seaboard to a global superpower.



The U.S. Army has grown with the nation it has served so well. Our Army has been an essential part of America's rise, first as the defensive shield of the republic during its early vulnerable years and later as a means to protect American interests around the world.

Today, with America fully engaged in the fight against terrorism, reliance on the Army is greater than ever. At this very moment, 260,000 Soldiers are deployed or "forward stationed" in nearly 80 countries overseas. In this era of persistent conflict, these quarter-million-plus men and women are exposed to great stress and pressure. Yet they, and the entire Army, are strong, combat-seasoned, competent and resilient. They are Army Strong, the strength of the nation.



Aviation stands alone: 2-135th named Army National Guard Aviation Unit of the Year

Did you know that the Army aviation branch is only 25 years old? As we celebrate this silver anniversary of Army aviation excellence we recognize the 2-135th aviation battalion, Colorado Army National Guard, for being selected as the Army National Guard Aviation Unit of the Year.

The unit, recently commanded by Lt. Col. Chris Petty with help from his Command Sgt. Maj., Douglas Imfeld achieved remarkable success. The 2nd Battalion 135th Aviation Regiment, a general support aviation battalion of the COARNG, deployed as Task Force Blackjack with the 36th Combat Aviation Brigade. The 2-135th Aviation was part of the theater aviation brigade in support of the Multinational Corps in Iraq.

The unit distinguished itself by not only deploying and transforming to a new force structure, but effectively assembled a diverse team of assets from Colorado, Arkansas, Florida, Minnesota, Nebraska and Utah. The team, consisting of more than 670 Soldiers and 46 helicopters was a formidable force that represented the best of Army National Guard aviation. Blackjack accumulated numerous achievements in support of Operation Iraqi Freedom. Most notably, they conducted 111 night air assault missions in support of the Joint Special Operations Task Force, inserting more than 15,500 Troops into landing zones across Iraq. Blackjack's crews flew 23,000 combat hours, 16,000 of which were under difficult night vision systems operations.

They launched and recovered more than 5,400 combat missions; and conducted medical evacuation flights for over 6,600 patients, 1,700 being "urgent" life-saving missions.

All of this was accomplished without any loss of life or any significant non-enemy induced aircraft damage. A few notable standouts include Sgt. Heather Springer, a flight Medic from C Co, who was awarded a Bronze star with 'valor' for her actions under enemy fire attending to the wounded. Chief Warrant Officer Scott Upton, a pilot, was awarded the Distinguished Flying Cross for his actions saving his crew and passengers after his aircraft was shot down by enemy fire. The battalion also awarded three Purple Hearts to crewmembers who received wounds from enemy fire in flight. The Soldiers of the 2-135th Aviation clearly demonstrated their incredible strength, experience and the "can-do" spirit of the Guard, earning the Army Aviation Association of America's Army National Guard Aviation Unit of the Year.

## Army Increases Activity to Encourage Small Business Programs

The Secretary of the Army issued a memorandum encouraging Army leadership to increase efforts to award contracts to small businesses owned by service-disabled veterans. In 2007, the Army awarded \$916 million in contracts to small businesses owned by service-disabled veterans. The new 2008 goal is to increase the contracts by 3%. The Foundation, working in conjunction with the city of Thornton, has arranged to have this extraordinary memorial present from July 3 to July 7, 2008 - most fittingly during the city's Independence Day celebration.

The Wall will be available for public viewing 24 hours a day on those dates at the multipurpose fields at the Margaret W. Carpenter Recreation Center (11151 Colorado Boulevard, Thornton, CO 80233).

[The Vietnam Traveling Memorial Wall is a 3/5 scale of the Vietnam War Memorial in Washington, D.C. It covers 288 feet with each wing being 144 feet in length and is over six feet tall. It is engraved with the over 58,000 names of those who paid the ultimate sacrifice during the Vietnam War.]

Bill would allow TRICARE Standard for "Gray Area" Retirees

Rep. Robert Latta, R-Ohio, recently introduced H.R. 6185, the TRICARE Continuity of Coverage for National Guard and Reserve Families Act of 2008. AUSA, along with its counterparts in the Military Coalition, supports this bill.

H.R. 6185 would allow members of the Guard and reserve in the "gray area" to purchase TRICARE Standard health care coverage. "Gray Area" individuals are Reserve component retirees under the age of sixty with 20 years or more of faithful and honorable service who are qualified for non-regular retired pay at age 60. There are approximately 220,000 members currently in the "gray area", with 12,100 members retiring and entering this status per year.

The legislation would allow qualified individuals to purchase TRICARE Standard coverage for 100 percent of the premium. Spouses and dependents can continue purchasing TRICARE at 100 percent of the premium if the retired reservist passes away before reaching age 60 and the member had been eligible at the time of death for TRICARE Standard coverage.
